The \$500.00 deposit cannot be deferred using Financial Aid or Installment Payment Plan.
2. This is an estimate of **minimum** out-of-pocket expenses. The estimate does not include personal entertainment, independent travel abroad or fluctuations in exchange rates.
3. Students should be prepared to pay housing deposit of approximately \$900 when securing academic year housing.
4. You will be asked to enter the **TOTAL ESTIMATED PROGRAM COST** amount on the Financial Data questionnaire.
