PLEASE NOTE THE FOLLOWING:

1. The **TOTAL PREPAID COSTS** is due to International Programs by May 1st. You may defer paying the balance of the prepaid cost, minus the \$500.00 deposit, using Financial Aid or sign up for the Installment Payment Plan. The \$500.00 deposit cannot be deferred using Financial Aid or Installment Payment Plan.
2. This is an estimate of **minimum** out-of-pocket expenses. The estimate does not include personal entertainment, independent travel abroad or fluctuations in exchange rates.
3. Arrival expenses include charges for PRC residency fee, PKU internet fee, police registration fee, and other various deposits.
4. On-campus housing is required and this is the minimum amount to cover the cost of rental deposits and pre-payment.
5. You will be asked to enter the **TOTAL ESTIMATED PROGRAM COST** amount on the Financial Data questionnaire.
