PLEASE NOTE THE FOLLOWING:

1. The **TOTAL PREPAID COSTS** is due to International Programs by May 1st. You may defer paying the balance of the prepaid cost, minus the \$500.00 deposit, using Financial Aid or sign up for the Installment Payment Plan. The \$500.00 deposit can not be deferred using Financial Aid or Installment Payment Plan.
2. Covers the cost for mandatory orientation program during the PLP.
3. This is an estimate of **minimum** out-of-pocket expenses. The estimate does not include personal entertainment, independent travel abroad or fluctuations in exchange rates.
4. Students should be prepared to pay for the related medical exam for this immigration requirement.
