PLEASE NOTE THE FOLLOWING:

1. The **TOTAL PREPAID COSTS** is due to International Programs by May 1st. You may defer paying the balance of the prepaid cost, minus the \$500.00 deposit, using Financial Aid or sign up for the Installment Payment Plan. The \$500.00 deposit can not be deferred using Financial Aid or Installment Payment Plan.
2. Please have an unlock phone. If an unlock phone is not available, student may borrow one at the Study Center.
3. This is an estimate of **minimum** out-of-pocket expenses. The estimate does not include personal entertainment, independent travel abroad or fluctuations in exchange rates.
4. Students should be prepared to pay significant expenses shortly after arrival for housing (first and last month's rent, security deposit, etc.).
5. You will be asked to enter the **TOTAL ESTIMATED PROGRAM COST** amount on the Financial Data questionnaire.
