The \$500.00 deposit can not be deferred using Financial Aid or Installment Payment Plan.
3. This is an estimate of **minimum** out-of-pocket expenses. The estimate does not include personal entertainment, independent travel abroad or fluctuations in exchange rates.
3. Students should be prepared for significant expense of up to \$1,500 shortly after arrival for room deposits and first month's rent.
