As part of the application process, exchange students are required to furnish verification of finances for the amount listed for the campus (or campuses) that they have listed on their application.

All students are required to purchase health insurance that covers the exchange period. Most campuses require that students purchase their health insurance regardless of whether the student has health insurance from their home country.

Campus-based fees are not covered by the exchange agreement and are subject to change (or added where not indicated). Fees are due upon invoice. Nonpayment of fees by the deadline date can result in disenrollment in classes, registration holds, non-release of the final transcript or dismissal from exchange.

In addition to campus-based fees (where listed), students may incur course fees that are not covered by exchange (for course supplies, lab fees or field trips).
